#### **MINUTES**

A motion was made by M. Tolmer, seconded by J. Colosimo approving the minutes of the November 11, 2013 regular meeting as submitted. All in favor, motion carried 7-0.

A motion was made by B. Ghelarducci, seconded by M. Tolmer approving the minutes of the November 19, 2013 budget workshop meeting as submitted. All in favor, motion carried 7-0.

# <u>CURRENT ESTIMATE NO. 4 AND FINAL – CONTRACT B – BOWER HILL ROAD IMPROVEMENTS</u>

A motion was made B. Ghelarducci, seconded by J. Colosimo approving the remittal of Current Estimate No. 4 and Final in the amount of \$90,208.23 to Peter J. Caruso for work completed to date on the Bower Hill Road Improvement Project. Remarks: Manager Collins stated that the estimate has been reviewed and certified by Engineer Sites. All in favor, motion carried 7-0.

# CURRENT ESTIMATE NO. 5 – 2013 SANITARY SEWER POINT REPAIR PROJECT

A motion was made by B. Ghelarducci, seconded by J. Sarasnick approving the remittal of Current Estimate No. 5 in the amount of \$37,776.69 to Insight Pipe Contracting, LP for work completed to date on the 2013 Sanitary Sewer Point Repair Project. Remarks: Manager Collins stated that estimates have been reviewed by Engineer Sites. All in favor, motion carried 7-0.

# **ORDINANCE NO. 976**

A motion was made by M. Tolmer, seconded by B. Ghelarducci approving Ordinance No. 976; an ordinance amending Ordinance No. 965 adopted the 12<sup>th</sup> day of December 2011 pertaining to general rates charged for sewage service given to the customers of the Allegheny County Sanitary Authority within the Borough of Bridgeville. Proposed rates are as follows:

# **RESOLUTION NO. 2013-11**

A motion was made by J. Sarasnick, seconded by M. Tolmer approving Resolution No. 2013-11; a resolution approving the Budget for the Fiscal Year 2014 and adopting the same. Remarks: Manager Collins stated that the proposed budget was advertised and available for public review beginning on Thursday November 21, 2013; therefore meeting the (10) day public review criteria. All in favor, motion carried 7-0.

# ORDINANCE NO. 977

A motion was made by B. Ghelarducci, seconded by J. Colosimo approving Ordinance No. 977; an ordinance fixing the Tax Rate and levying Borough Taxes for the Fiscal Year 2014 and re-enacting all other revenue acts. Remarks: Manager Collins stated that no real estate tax increases have been proposed in the Fiscal Year 2014 Budget. The ordinance has been duly advertised. All in favor, motion carried 7-0.

# JORDAN TAX SERVICE SANITARY SEWER COLLECTION AGREEMENT

A motion was made by J. Colosimo, seconded by B. Ghelarducci approving the agreement between Jordan Tax Service and the Bridgeville Borough designating Jordan as its exclusive agent for purposes of billing and collecting the Bridgeville Borough's current and delinquent sanitary sewage charges and fees, and any and all penalties, interest, costs, expenses

and attorney fees assessed and levied pursuant to all Borough resolutions and/or ordinances and any other applicable laws respecting said charges and fees. Remarks: Manager Collins stated that upon execution of this agreement, Jordan Tax will begin the sanitary sewer billing in January 2014. The agreement has been reviewed by Solicitor Ferris. We will be sending notification to our residents. All in favor, motion carried 7-0.

# **ORDINANCE NO. 978**

A motion was made by B. Ghelarducci, seconded by J. Sarasnick approving Ordinance No. 978; an ordinance adopting a schedule of attorney fees in connection with the collection of Municipal Claims and Municipal Liens pursuant to Act 1 of 1996 and Act 20 of 2003 and adopting a schedule of charges, expenses and fees pursuant to the Act of May 16, 1923, as amended, 53 P.S. §7101, §7103 and §7106, including Act 83 of 2004, which ordinance repeals any other ordinances inconsistent herewith relating to a schedule of attorney fees pursuant to Act 1 of 1996 or Act 20 of 2003. Remarks: Manager Collins stated that this ordinance permits the Bridgeville Borough to recover as part of each unpaid Delinquent Claim, among other things, various charges, expenses and fees and attorney fees relating to the failure to pay the Delinquent Sewage Claims promptly; and subsequently enforces collection of the same. The ordinance has been duly advertised. All in favor, motion carried 7-0.

# JORDAN TAX SERVICE SPECIAL COUNSEL AGREEMENT

A motion was made by B. Ghelarducci, seconded by M. Tolmer approving to use Jordan Tax Service's "Special Legal Counsel" Goehring, Rutter & Boehm to assist the Borough and Jordan Tax in the collection of the Municipality's Delinquent Sanitary Sewer Claims per the specifications set forth within the agreement. Remarks: Manager Collins stated that the agreement has been reviewed by Solicitor Ferris. All in favor, motion carried 7-0.

### **SOLICITOR FERRIS RESIGNATION**

A motion was made by B. Ghelarducci, seconded by M. Tolmer accepting the resignation of Solicitor Ferris effective January 1, 2014. Remarks: Manager Collins thanked Solicitor Ferris for his many years of service to the Bridgeville Borough. Remarks: N. Petrocelli, Sr. stated that Mr. Ferris has done a fantastic job since 1970 and he regrets and apologizes for all of the unprofessional comments he has had to endure. All in favor, motion carried 7-0.

#### PARKING AUTHORITY MEMBER RESIGNATION

A motion was made by B. Ghelarducci, seconded by J. Sarasnick accepting the resignation of Robert Eckles from the Parking Authority effective December 17, 2013. Mr. Eckles term expires the first Monday of January 2015. Remarks: Manager Collins thanked Mr. Eckles for his many years of service to the Bridgeville Borough. Remarks: N. Petrocelli, Sr. wishes him good luck. All in favor, motion carried 7-0.

# BOROUGH MANAGER, LORI COLLINS

This means that the Declaration covers all of Allegheny County's local governments, police departments, fire departments, emergency medical services, public works departments, water and sewer authorities, school districts, hospitals and certain private non-profit organizations. It does not cover residential loses. Reimbursable costs will include but are not limited to some damage to roads, bridges, buildings, debris removal, personnel cost and vehicle and equipment use. Fire Chief Chilleo and I will be attending an applicant briefing tomorrow from 1-5 p.m. We are required to attend and will be receiving forms to start all of our reporting. The Borough will be reimbursed for some of the cost that we expended due to the flooding.
